MCA PBE RVE	Review July 2024	All data passed onto each Pastoral Leader and actioned as per Anti-Bullying Policy. Increased awareness and vigilance has led to an increase in reporting. Most common bullying category is 'verbal bullying' but very little repeat offence - less than 1% of incidents. Assemblies and SMSC themes 23/24 include: Anti-Bullying; Autism Acceptance Week, Kindness, Black History Month, International Day for People with Disabilities; International Men's and Women's Days; Holocaust Memorial; LGBT History Month, Pride Month (Refugee Week still to run in summer term 2024). The Endurio Pulse Student Survey (Spring 2024) showed an improvement of 5% in student views since they were last asked if they had been bullied in the past three months. The result for this important safeguarding question was our best score of the whole survey at 87%.
